- Parents are a part of the PTO. In conjunction with parents; community stakeholders, business, and community partners are a part of these committees as well. Teachers, students, and school administrators share ownership on these committees to address and manage the needs of each school, parents, and community. All plans will be designed, edited, and evaluated by these groups.

 - Academic Content Standards and Behavior Support will be discussed during parent meetings or workshops. College and Career Ready Standards (COS) will be kept by all teachers for reference when conferencing through either hard copy or Internet.
 - Monthly progress reports will be given to parents. Report cards will also be given every nine weeks. Parents will be encouraged to schedule teacher conferences to have standards and students' progress explained and discussed.
 - Teachers will offer positive feedback to parents in addition to deficiencies to establish rapport and strengthen lines of parent/teacher communication. All of this will be tied together with the Parental and Community Engagement Liaison at Midfield Elementary School. This person will work with the school administrator, teachers, and district to identify school and parental needs. Liaisons will assist with programs and events within the school that will support and address the needs of the parents.

 - The liaison will work with each school to establish school websites and parent's section on the school website. Teachers and parents will be aware of the location of the Parent Resource Center at Midfield Elementary School. Parents will have access to these rooms at any time during operating school hours. Within each room the school and district will provide materials to support academic, behavior, social and emotional issues for children. The school will also provide attendance and literacy information within these rooms.

The Community Engagement Liaison will host quarterly events at Midfield Elementary School.

Liaisons will encourage individual teacher newsletters to be sent home regularly. Liaisons will encourage teachers to use Transact to translate any information that may need to go home in another language.

Midfield Elementary School will immediately address any request from parents through the school's parental and community engagement liaisons.

The school utilizes the after-school tutoring program for all other events held after-school and for all Early Dismissal Days.

The primary goal for the Parental Engagement team is to offer training for our parents in key areas related to literacy, mathematics, reading, and behavior intervention at Midfield Elementary School. A goal was set to offer more training directly to the parents in these key areas.

The school will host activities during school hours as well. The district is planning to support a bus route for all after school activities based on parental engagement and student assessment. The goal is to remove the barriers for those parents who can't come because of transportation and to provide the program during the day for those parents who work nights.

Parental Engagement Liaison will review and design programs to meet the needs of the families in Midfield based on suggestions from staff and community. All programs will be approved by the Midfield City Board of education prior to implementation.
