#### **School Responsibility:**

#### 1. Provide high-quality curriculum and instruction.

- Utilize the Alabama State Course of Study Standards as the basis for instruction in each subject. (On-line Curriculum: iReady, Reading Horizons, Imagine Math, Mastery Prep & School PLP)
- Employ the use of research-based instructional strategies including intensive and explicit instruction, small group instruction, targeted at each student's areas of challenge, academic support through tutoring, and other similar strategies. Virtual Face to Face Instructions
  - Provide students with multiple opportunities to master content standards

#### 2. Hold parent-teacher conferences.

- Two parent conference opportunities will be scheduled (One each semester) to coincide with issuing nine –week report cards or end of semester grading periods
- The compact will be utilized at additional conferences as mutually arranged between parent and teacher. Conferences may be held virtually.
- Share information through meeting or workshops held both during the school day and in the evening, or through ZOOM Meetings, when convenient for parents.

#### 3. Provide parents with reports on their child's progress.

- Progress reports are issued every four and a half weeks during the school year. Parents will have INOW Access Code to monitor grades daily or weekly.
- Students who are academically at-risk will be issued a progress report each week.
- Student progress in Reading and Math as measured in Benchmark Assessments will be shared with parents each fall, winter, and spring.
- Student Assessment Reports will be shared with parents and reviewed during conferences
- Report cards will be issued at the end of each nine-week grading period or end of 18 week grading period, when applicable.

#### 4. Provide parents reasonable access to staff.

- Conferences are scheduled through appointments on each of the two parent conference opportunities. Contact teacher for additional or Virtual Meeting Request
- Teachers will attempt to respond quickly (within one day) by phone calls, notes, emails, or requests for conferences.
- Teachers will initiate contact with parents whenever, academic, attendance or behavior changes warrant.
- Teachers will notify parents when students excel and not only when there are problems

#### 5. Provide parents opportunities to volunteer.

- Parents are invited to participate as classroom volunteers, guest readers/speakers, fieldtrip chaperones, and other similar activities.
- Parents are encouraged to join the Parent-Teacher Organization.
- As stated in Student Handbook, parents may observe classroom activities at a time arranged by the school administration.
- Numerous special events invite parent participation including but not limited to Parent Summits, Career Day, Focus Groups, Spring Fling, and Student Recognitions programs. Parents are encouraged to act as reading and/or math tutors.

## 6. Ensure regular two-way meaningful communication between family members and staff, to the extent practicable, in a language family members can understand.
